Keynote Address. -Surili Sutaria Patel

Surili is a trusted voice in public health who champions diversity and works to advance health equity and environmental justice. She approaches health and the environment through thoughtful coalition building and innovative strategies that work to advance equity and improve access. With a profound public health and biomedical research background, she has led the climate and health discussion out of environmental circles and into the broader public health realm.

Surili is a Vice President at the Metropolitan Group – a full-service strategy and creative agency that works exclusively with public agencies, nonprofits, foundations and socially responsible businesses to build a just and sustainable world. At the Metropolitan Group, a certified B Corp, Surili works at the intersection of public health, environment and sustainability and social justice.

Previously, Surili held a visionary leadership position at the American Public Health Association, where she drove strategic development to bridge the gap between public health practice and sound policies. As the architect and director of the Center for Climate, Health and Equity, she inspired action by public health professionals and advanced policy agendas that address health at the nexus of climate and equity. As deputy director for the Center for Public Health Policy, she elevated the association's environmental health program to the national stage. Surili also has deep issue-based knowledge in environmental health priorities including water safety and security, children's environmental health, Tribal public and environmental health, transportation and health, and healthy community design.

Surili is the co-founder of Aawaz for Climate, a new network that addresses climate change and health equity through elevating voices represented in a gender and ethnically diverse community.

Tools for Local Climate Action

In the midst of an ongoing climate crisis, the United Nations has issued a “code red for humanity.” NJ is responding aggressively with policies, programs and tools to reduce our greenhouse gas emissions by 80% by 2050. The NJ Climate Change Resource Center has collected and integrated a wide variety of information to provide education and outreach support for policy initiatives. Landfills are the third-largest source of methane emissions and a quarter of what we dispose of is food waste. How is NJ tackling the food waste problem statewide and locally? Moving Forward with Electric Vehicles

Did you know that the transportation sector accounts for 42% of the greenhouse gas emissions in New Jersey, making it the largest emissions source? The NJ Energy Master Plan calls for 100 percent carbon-neutral electricity generation and maximum electrification of the transportation and building sectors by 2050. Transitioning to EVs is a transformative step toward eliminating the dominant source of local air pollution (including black carbon), especially in EJ communities that have been disproportionately impacted by poor air quality. In this session, learn how your municipality can embrace the EV revolution through passage of local ordinances and utilization of grants and incentive programs. One such opportunity has led to a pilot electric shared mobility project being launched in Trenton.
