GOAL NO. 1: Promote Environmental Awareness and Communicate Environmental Issues to the Public

1. Continue to support the Community Gardens in Naaman Williams Park and at the Pine Grove Manor School. Support the planned new Community Garden at Catalpa Park.

- 2. Continue the Environmental Stewardship Awards program for outstanding environmental contributions by a citizen and a group or local business

- 4. Sponsor a "Build a Rain Barrel Workshop" by the NJ Water Supply Authority in the Spring
- 5. Sponsor and participate in a stream cleanup in April

- 8. Serve as an advocate for expanded use of renewable energy within the Township
- 9. Serve as a resource for residents regarding environmental questions and issues

OBJECTIVES:

1. Review and comment on site plans for residential, non-profit, and commercial development

- 2. Provide support to the Township for the Somerset County Improvement Authority's Renewable Energy Initiative Program
- 3. Coordinate and hold joint meetings with the Township Advisory Board of Health
- 4. Develop resolutions on environmental issues affecting the Township
- 5. Coordinate with ANJEC on policy statements regarding environmental issues

6. Work with the Green Team in leading the Township's efforts to continue to grow as a sustainable community with Bronze, Silver, Gold or Platinum status

7. Continue to assist the Stony Brook- Millstone Watershed Association in their efforts to remove, the one remaining, of two dams on the Millstone River in Franklin Township

8. Gather information and develop an integrated pest management policy for the Township

9. Represent the Township in the Sustainable Raritan River Initiative program sponsored by the Rutgers University Bloustein School of Planning and Public Policy

10. Work with the New Jersey Water Supply Authority regarding the proposed dredging of the Delaware and Raritan Canal to minimize environmental damage

- 11. Be an advocate for LEED Certified buildings in the Township
- 12. Support ANJEC with their project to promote access to the lower Raritan River
- 13. Assist and support the Millstone River Flood Commission with their efforts to alleviate flooding in the Millstone River basin

Bloodroot (Sanguinaria canadensis), a lovely early bloomer, is not a true ephemeral because it doesn't go dormant and disappear after flowering: its foliage thrives through autumn. Its seeds are spread by ants (so thank an ant when you see Bloodroot!).

How to get there: Enter Drew campus at the intersection of Madison Ave. and Lancaster Rd., then keep going straight until you reach the Zuck Arboretum gate (past the sports fields and the Simon Forum and Athletic Center). Here's a <u>trail guide</u>.

- Give them a heads up when something newsworthy is going to happen.
- Follow up with synopsis of what happened & offer phone interview.
- Offer seasonal environmental story ideas.
- Take advantage of slow news periods – provide content.
- Post your own news on online media, i.e. *Patch* and town list serves.

Stormwater Display Clean Water for Your Town

Explains the environmental effects of rain and stormwater, what the State requires your town to do and what you can do. Your town can prevent pollution run-off by encouraging environmentally friendly lawn care procedures, enacting water protection ordinances like requiring pet waste pick-up and proper septic system maintenance. Also, display shows how stream buffers help water quality and why you need stormwater control for new development.

Habitat Protection Game

This fun card game tests your habitat protection savvy. Roll the dice to get a question in one of 6 categories. Includes info about benefits of habitat, causes and effects of habitat loss and how to protect habitat in your town.



Green Infrastructure

Three panel display with information about reducing stormwater pollution and flooding threats by using techniques such as placing rain barrels, disconnecting downspouts, constructing pervious paving systems, and creating rain gardens.



Climate Change Pin Ball

Test your knowledge with six climate change topics. Questions range from human behavior, energy, causes and effects and more.
